

Public Cloud Management - Managed AWS - Core Services

1.1 Overview

This service provides the configuration, monitoring and management of the core services in an AWS environment which are specified as In Scope in the SOW.

(a) Supported Configurations

- Client account not linked to an NTT Master Payer Account
- Client account linked to an NTT - End Client Master Payer Account
- Client account linked to an NTT - Reseller Master Payer Account

In each scenario, the Client retains ownership of their AWS account.

(b) Client Responsibilities

- A minimum of Business Level Support from AWS is required on all managed accounts.

(c) AWS Access Management Prerequisites

In order for NTT to manage the Client's AWS environment, the following requirements must be met:

- AWS Account with root access; or
- AWS Account with IAM user with full Administrative rights

(d) Core Services

 - Managed Network

- Managed Cloud Identity
